ICS research identifies effective practices in early childhood health, education, policy, and financing and examines methods to implement best practices and identify promising practices.



Studies and analysis were completed this year supporting the ICS research pillar. These include:

Publishing Investing in Early Childhood: The Path to a More Prosperous South Carolina—a comprehensive ICS study making the business case for smart investments in early childhood as a means for promoting economic prosperity, improving workforce development, and reducing public expenditures for remediation programs.

Partnering with Dr. Steven Mann of the Moore School of Business at the University of South Carolina to design a study to determine the feasibility of using Social Impact Bonds (SIBs) as a financial instrument for scaling and sustaining high-quality interventions for young children.

Completing an Ideal Systems/Ready Communities Gap Analysis examining seven underserved neighborhoods in Greenville County with the Clemson University Eugene T. Moore School of Education.

Launching a feasibility study led by New York University's Megan Golden to establish the viability of using a Social Impact Bond for scaling and sustaining the Nurse-Family Partnership home visiting intervention with The Duke Endowment and the South Carolina Department of Health and Human Services.

With the University of North Carolina at Charlotte, finalizing a comprehensive logic model and evaluation plan for ICS, focusing on both the proximal and distal outcomes the Institute seeks to acheive.



ICS policy and advocacy initiatives build consensus, support, and funding for early childhood services, interventions, policies, and legislation aimed at improving early childhood outcomes.

Of South Carolin heard the message that Kids Drive Our Future.

This comprehensive statewide business advocacy campaign, developed by ICS with support from the United Way Association of South Carolina and the Mary Black Foundation, targeted corporate leaders with the message of smart early childhood investment.



Attended the first ever South Carolina Economic Forum on Early Childhood Investment

hosted by ICS and held in Columbia in February 2013. These 200 leaders represented corporations, lawmakers, government agencies, universities, hospitals, and the social sector. Participants were issued a 'call to action' offering concrete measures for building a stronger early childhood system in South Carolina and asking for their support of ICS legislative priorities.

Civic and corporate leaders attended one of 8 business leader summits

on early childhood investment in cities and towns throughout South Carolina. These summits were facilitated by ICS with support from the Pew Center on the States, Ready Nation, area United Way organizations, and local chambers of commerce.



21 Senators and 35 Representatives co-sponsored ICS

developed reform legislation introduced to the South Carolina General Assembly for consideration during deliberations surrounding the reauthorization of South Carolina First Steps. The proposed reforms include measures to advance a statewide definition of "school readiness" and to promote proliferation of evidencebased early childhood interventions.



ICS integration efforts increase the knowledge base among partners and promote collaboration and alignment so that best practices and research-based approaches are implemented across sectors and disciplines.

Thought-Leader Assemblies were hosted by ICS

throughout the state, with partners such as the Riley Institute at Furman University, Help Me Grow South Carolina, and Nurse-Family Partnership. These assemblies bring national and regional experts to South Carolina to share their expertise on issues impacting healthy early childhood development, systems change, and the implementation of best practices.



Concrete strategies for enhancing South Carolina's early childhood environment

were offered to hundreds of business leaders across the state through the ICS *Toolkit for Employers*. The toolkit offers the business sector resources and ideas for supporting affordable child care, developing child-friendly policies, increasing access to quality child care, and promoting purchased-space and discount child care programs.



Of families will benefit from the launch of *Kids Drive Greenville*

A collaboration of ICS, Greenville First Steps, and the United Way of Greenville County. This educational web portal connects Greenville County families, educators, health care providers and business leaders to resources that help them find, deliver, and invest in quality care and education.



Regional leaders

from drawn government, the philanthropic community, early childhood interventions, and the business community, were convened by ICS to form the South Carolina Social Impact Finance Working Group. This group is developing a knowledge base around innovative financing arrangements for programs that produce social benefits and cost savings. The group is considering the potential of social impact financing to improve outcomes for children on a large scale.

Moving Forward

In addition to its ongoing research and advocacy work, major ICS objectives for the upcoming year include:

POLICY AND ADVOCACY

Facilitating passage of the School Readiness/First Steps reform legislation drafted by ICS and introduced in the South Carolina Senate and House in January 2013.

Seeking passage of legislation to update the "Infants and Toddlers with Disabilities Act" to comply with current Federal law under the Individuals with Disabilities Education Act .

Hosting additional regional business leader summits on early childhood investment to build further support for smart early childhood investment in South Carolina.

INTEGRATION



Launching the first early childhood Social Impact Bond pilot in the United States, with the aim of scaling and sustaining the Nurse-Family Partnership home visiting program.

Initiating the ICS Fellowship Program, a yearlong program seeking to develop the next generation of South Carolina's early childhood leaders by providing participants with tools for stimulating more effective, creative, and transformative work in the state's early childhood sector and promoting a more effective system for the success of every child.

Continuing the work of the Social Impact Finance Working Group to prepare South Carolina's leaders for the implementation of an early childhood Social Impact Bond pilot and to promote ongoing dialogue focused on innovative and new techniques for financing and sustaining evidence-based early childhood interventions.

RESEARCH

Hosting the first South Carolina Early Childhood Research Symposium to serve as a forum for the exchange of ideas among early childhood researchers representing the health, education, safety, policy, and economic sectors. The symposium will showcase early childhood research being undertaken by universities, hospitals, and other organizations across South Carolina.

With the Center for Leadership in Law and Education at Clemson University, collaborating to produce a study comparing early childhood policies across states and recommending the most effective policies for consideration by South Carolina lawmakers.

Publishing a comprehensive issue brief on 4K in South Carolina to help frame and inform ongoing discussions surrounding efforts to strengthen and expand publicly-funded 4K in our state.

Working with research partners at the Clemson University Eugene T. Moore School of Education, completing an early childhood ideal system assessment and gap analysis of Barnwell and other rural counties..
